Control the costs associated with your payments by switching from paper checks to ACH payments.

More businesses are using automated clearing house (ACH) transfers to simplify payments to vendors and suppliers. When you make a payment using ACH, your bank works for you. The funds come directly from your bank account, unlike a check that can be delayed or lost in transit.

ACH payments are a safer, faster and more efficient payment method than mailing paper checks.

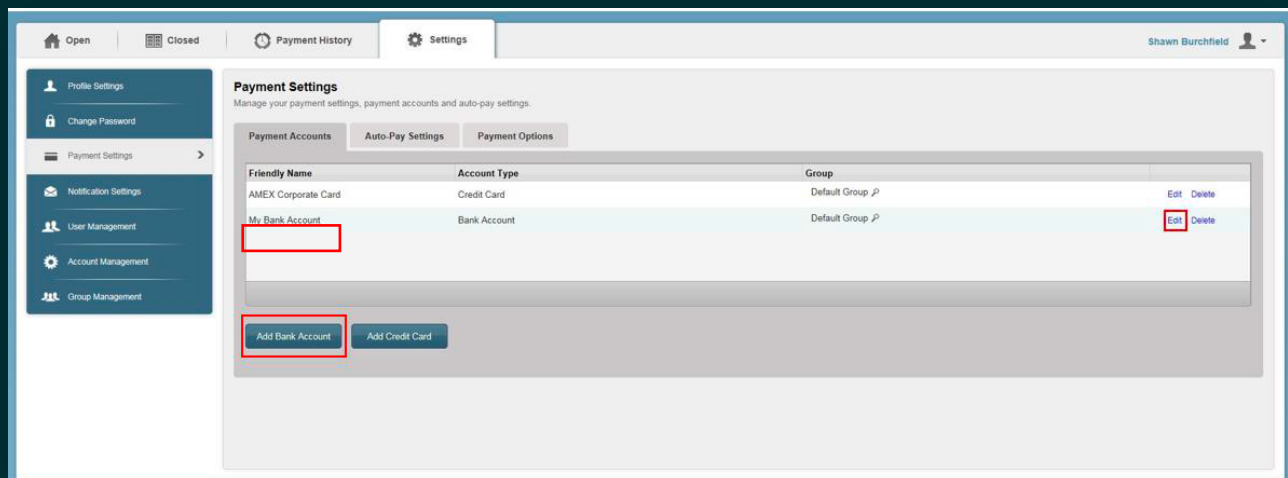
## Let me show you how it works

Getting started – In Settings, go to the Payment Settings tab

Under Payment Settings, click the Payments Accounts tab. The following view appears:



You may Add or Edit a Bank Account. If adding a new Bank Account, press the Add Bank button.

The following screen will appear.  
Enter the following information.

- A Field Description:** Enter a friendly name to associate with the account.
- B Bank Name:** Enter the name of the paying bank.
- C Name on Account:** Enter the first and last name of the bank account owner.
- D Routing Number:** Enter the routing number located next to the symbol on the bank's check.
- E Account Number:** Enter the account number located next to the symbol on the bank's check.
- F Retype Account Number:** Enter the prior bank account number as a confirmation.
